

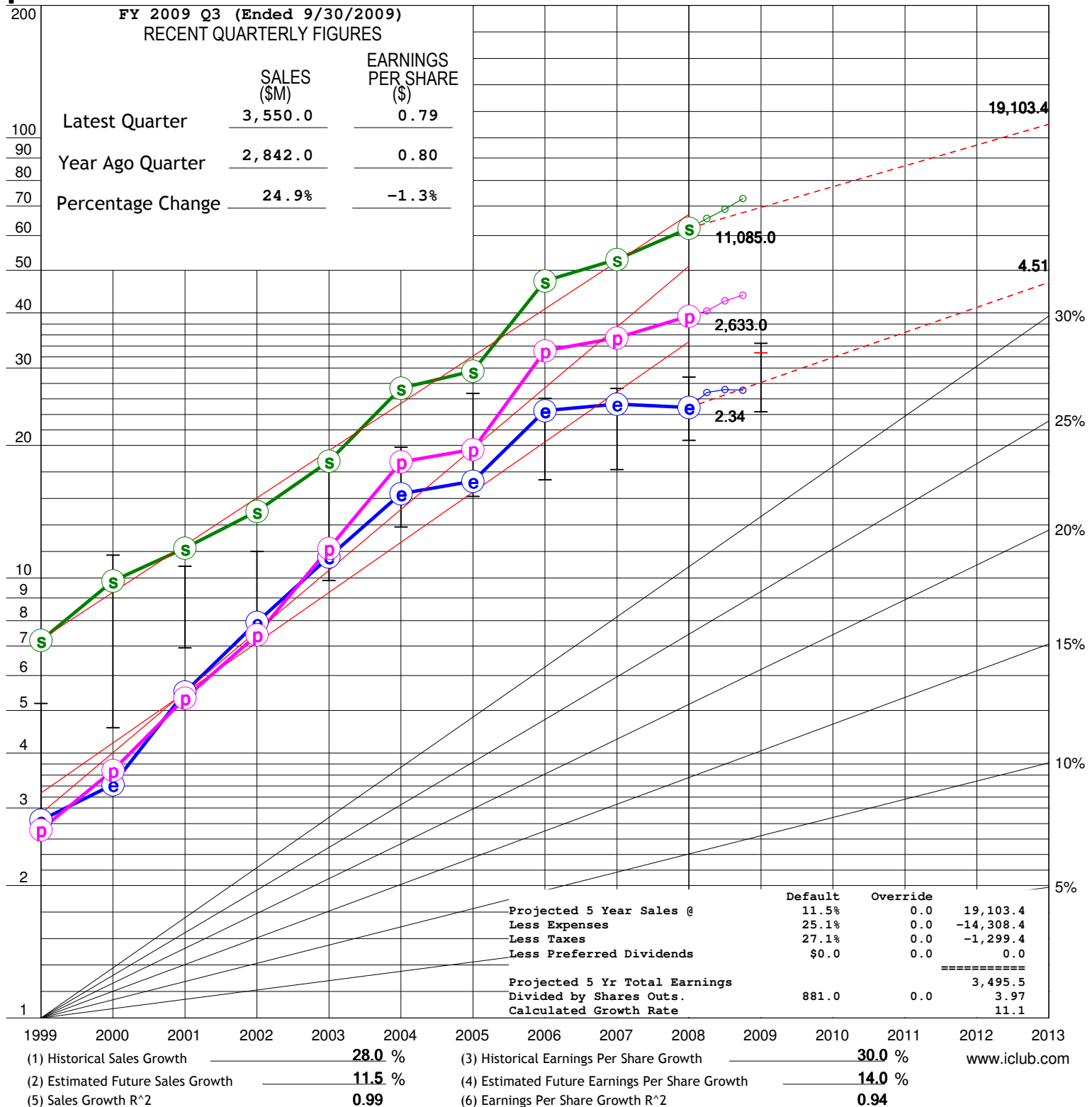

### A FUTURE HIGH PRICE ANALYSIS -- NEXT 5 YEARS

Selected High P/E **22.6** X Estimated High Earnings/Share **4.51** = Forecast High Price \$ **101.9**

### B FUTURE LOW PRICE ANALYSIS -- NEXT 5 YEARS

(a) Avg. Low P/E **14.6** X Estimated Low Earnings/Share **2.34** = \$ **34.2**  
(as adj.)

(b) Average 5-Year Low Price = **29.1**

(c) Recent Severe Low Price = **30.8**

(d) Price Dividend Will Support = Present Divd. ÷ High Yield = **0.603 ÷ 0.014 = 43.9**

Selected Estimated Low Price = \$ **29.1**

### C PRICE RANGES

Forecast High Price **101.9** - Estimated Low Price **29.1** = Range **72.8** 25% of Range = **18.2**

BUY (Lower 25% of Range) = **29.1** to **47.3**

MAYBE (Middle 50% of Range) = **47.3** to **83.7**

SELL (Upper 25% of Range) = **83.7** to **101.9**

Current Price **56.760** is in the **Hold** Range

### D REWARD/RISK ANALYSIS (Potential Gain vs. Risk of Loss)

(Forecast High Price **101.9** - Current Price **56.760**) ÷ (Current Price **56.760** - Estimated Low Price **29.1**) = **1.6** To 1

## 5 TOTAL RETURN ANALYSIS

### A CURRENT YIELD

Present Full Year's Dividend \$ **0.603** ÷ Current Price of Stock \$ **56.760** = **1.1 %** Present Yield or % Returned on Purchase Price

### B AVERAGE YIELD OVER NEXT 5 YEARS

(Avg. EPS Next 5 Years **3.47** X Avg. % Payout **16.1** 16.1) ÷ Current Price \$ **56.760** = **1.0 %**

### C % COMPOUND ANNUAL TOTAL RETURN

Average Yield **0.7 %** + Annual Appreciation **12.4 %** = Compound Annual Total Return **13.1 %**

### D % PROJECTED AVERAGE RETURN

Average Yield **0.9 %** + Annual Appreciation **8.1 %** = Projected Average Total Return **9.0 %**
