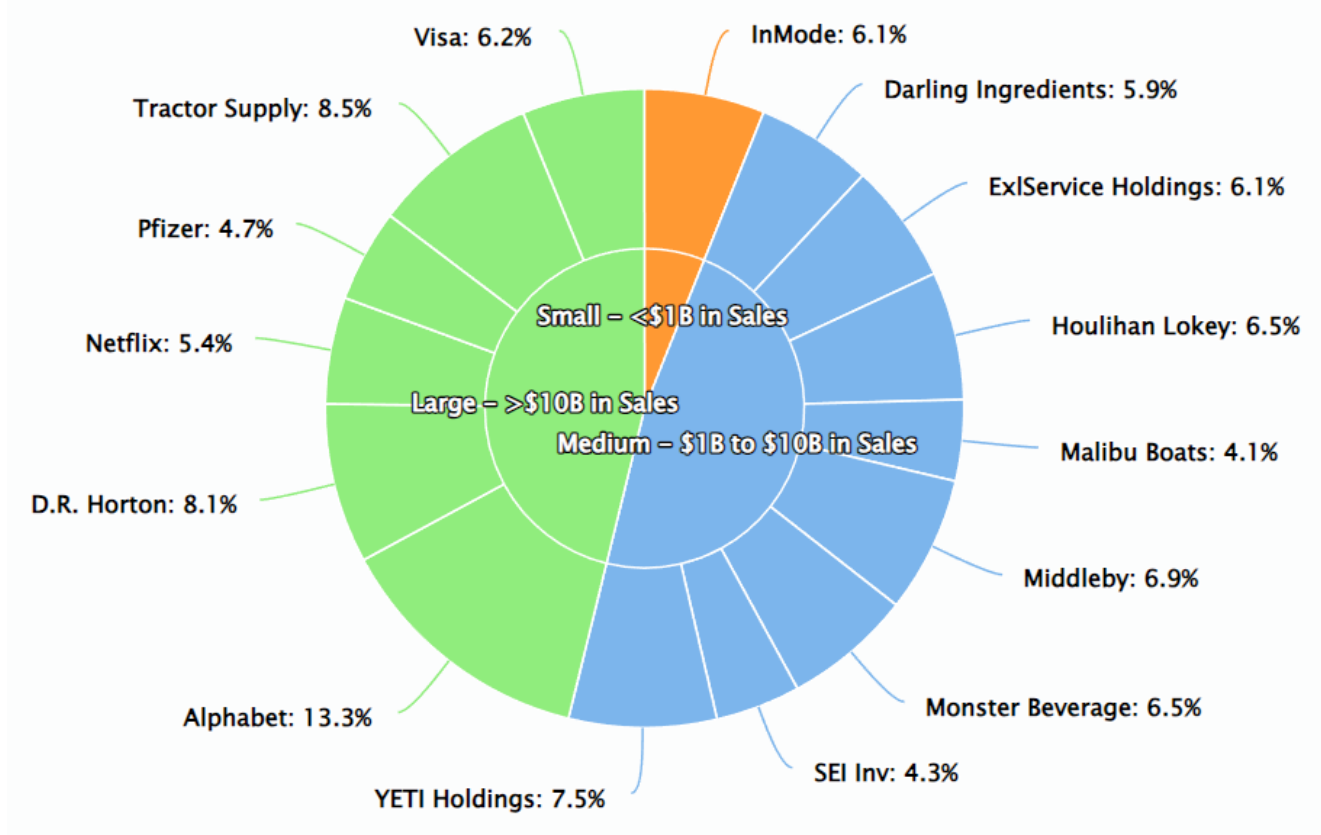

**Stock Study Presentation** – Ira presented an SSG for Kinsale Capital Group (KNSL) and provided a thorough analysis of the stock, an overview of the company and how it is positioned for the future. KNSL is a small, specialty insurance company that takes on higher risk than other insurers. (It is just under the \$1B in annual sales to make it a small company. I found a comment that Altman-Z does not apply to banks or insurance companies, so the 5.2 score that Sriram found is not applicable. This might also explain why Ira couldn't find it on Chartmill.)

**Review of Stock Portfolio:** Members presented their updates for stocks they were watching. Ira showed the Bivio Valuation Report during the individual presentations. Sriram showed the dashboard for the Yankee portfolio from Manifest Investing. Sriram also showed his version of the PERT chart for the Yankee portfolio, which has lots of red on it indicating missing sales and earnings milestones. Sriram would like everyone to send him updated SSGs for each of the stocks they follow. A visitor suggested that the date be embedded in the title of the SSG file.

**Watchlist update:** Small – TGLS (Hold) and XPEL (BUY)  
Medium – GNTX (Hold), PAYC (BUY) and PAYX (Hold)

**Backburner List:** No discussion.

**Buy/Sell decisions** – After discussion, the club decided to make the following trades:

**SELL:** 10 shares of GOOG and 10 shares of GOOGL. **BUY:** Use all available cash to buy KNSL.

**Old:**

- OLC Portfolio challenge:
  - We have until March 1<sup>st</sup> to modify the portfolio. We will hold onto our winner (PLNT) and replace our losers with the highest 3 PAR stocks in the Manifest list. Last month we chose CPRX and SEDG to replace HIFS and ENPH. Should we find a stock to replace CHGG?
  - We ‘invested’ \$25,000 (virtually) each in HIFS, CHGG, PLNT and ENPH for the Online Chapter 2023-2024 Stock Picking Contest. We are down 4.9% so far, which puts us sixth (out of 6) in the contest. The S&P500 is up 11.1% and the leader is up 17.5%. The link for the contest is:
