

**Stock Study Presentation** – Jessica presented an SSG for Iradimed, Corp. (IRMD) and provided a thorough analysis of the stock, an overview of the company and how it is positioned for the future.

**Review of Stock Portfolio:** Members presented their updates for stocks they were watching. Sriram showed the dashboard for the Yankee portfolio from Manifest Investing and the PERT chart for the Yankee portfolio, which has lots of red on it indicating missing sales and earnings milestones.

Watchlist update: Small – QLYS (HOLD)

Medium – FTNT (BUY), GNTX (BUY), PAYC (BUY) and PAYX (BUY)

Backburner List: No discussion.

**Buy/Sell decisions** – Ira Haas resigned as of the August meeting. Ira's share of the club was about 28.6% of club assets or \$76,064.05. After discussion, the club decided to make the following trades:

**SELL:** All of DLO, XPEL, KNSL, INMD and YETI.

**TRANSFER to Ira**: 127sh. of MIDD (all), 40sh. of HLI, 10sh. of TSCO, 12sh. of GOOG and 12sh. of GOOGL, plus \$47,295.45. Transfer from Yankee's Fidelity account to Ira's Fidelity account.

  - We 'invested' \$25,000 (virtually) each in HIFS, CHGG, PLNT and ENPH for the Online Chapter 2023-2024 Stock Picking Contest. We are down about 17.2% so far, which puts us sixth (out of 6) in the contest. The S&P500 is up 18% and the leader is up 36%.
